Eligibility/Pre-Qualification Criteria

- 1. Bidder should be a registered company.
- 2. Bidder need to provide attested Photocopies of PAN card and Service Tax registration of the company.
- 3. Must have carried out geological and geotechnical investigation of two or more hydroelectric projects of capacity more than 50 MW.
- 4. Must have experience in the geotechnical investigations of Tunnels.
- 5. Turn over of the company must be more than 50 lakhs per year in the last three years.

2. Cost of document for Tender:

This document can only be downloaded by the bidders from the official website of UPDCC Ltd www.updcc.org. Parties downloading the document from the official website of UPDCC Ltd shall enclose the demand draft amounting to Rs 570.0 (inclusive of 13.5% trade tax) in favour of "M/S Uttarakhand Project Development and Construction Corporation Ltd.", payable at Dehradun along with their Tender as a cost of document.

- 3. The successful bidder shall be required to enter into an agreement with the undersigned on behalf of the Nigam for proper completion of the work. For which, the following documents have to be provided by the bidder:
 - a) Rs 100/- non judicial stamp paper.
 - b) Performance security 10% of the minimum bidding amount in form of Bank Guarantee, FDR etc. In case the bidder is willing to submit 5% performance security at the time of signing of the agreement the remaining 5% shall be deducted from bills.

The total quoted amount (in Indian Rupees) shall be inclusive of all taxes and duties viz. Service tax etc. However Service tax shall be shown separately. Consultant has to furnish documentary proof regarding submission of Service tax then only it will be reimbursed.

- 4. PERIOD FOR THE WORK: After issuing letter of award the work has to be completed within a period of 60 days. However, the bidder should earnestly make all efforts to complete the work in the minimum possible time.
- 5. PAYMENT FOR THE WORK: Item-wise payment shall be released after completion of the work as per satisfaction of the nigam authorities/its consultant.
